THE CERTIFICATE IS ISSUED SUBJECT TO THE FOLLOWING CONDITIONS

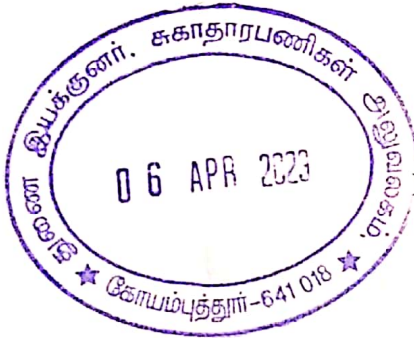
1. The activities in this premises shall not cause any nuisance to Public
2. Physical distancing of at least one meter to be followed at all times inside the premises
3. Use of face covers/masks to be mandatory for all inmates and visitors.
4. Hand washing facilities or Sanitizers shall be provided at all the entry points and Wherever necessary
5. The Premises shall be disinfected with Lysol or Sodium hypo chloride solution at an hourly basis
6. Ensure that only "Fully vaccinated for Covid " persons are allowed inside the premises
7. Necessary arrangements to be made to remove the garbages then and there with the approved method of the Local body

8. The premise must be free from Mosquito Breeding Sources
9. The Water Storage facilities must be covered with suitable lids and Chlorination of water shall be monitored for every fillings. The residual chlorine shall be maintained at 0.2 ppm at all the time.
10. The Rules under Tamilnadu Prohibition of Smoking and Spitting Act,2002 should be followed in the premises
11. Emergency exit shall be provided in all the floor
12. Sanitary Napkins of adequate quantity conforming to relevant Indian Standards formulated by Bureau of Indian Standards shall be provided and maintained in the women's toilets for their use, and the same shall be replenished on daily basis.
13. Disposable bins with lids shall be provided within the women's toilets for the collection of the used sanitary napkins. The used sanitary napkins shall be disposed off in a safe, hygienic and eco-friendly process by using suitable electrical incinerator";
14. This Certificate is valid for the period of one year from the date of issue.
