SANITARY CERTIFICATE

CHAPTER V

(Sec 38 of Tamilnadu Public Health Act,1939)

I hereby declare that I have inspected the Premises of Honey Bunch School, Thoppampatti Village, Vellalalayam Post, Pollachi -642120 Coimbatore District building and premises on the day of 03.04.2024 and certify

- The Class rooms and their surroundings are maintained neat and clean
- The Sanitary arrangements provided are adequate and satisfactory

THE CERTIFICATE IS ISSUED SUBJECT TO THE FOLLOWING CONDITIONS

19. On any account , the Garbage shall not be burnt or kept more than 24 hours in the premises and should be collected and disposed by appointing required sanitary staff
20. Usage of plastic is prohibited
21. Fire precautionary measures and First Aid box should be provided
22. Child labour should not be engaged on any account
23. Over Head Tank and water sump shall be hermetically sealed and scientifically closed and shall not be breeding sources of mosquitoes.
24. Drinking water shall be chlorinated and shall have 0.5 ppm of residual chlorine.
25. Fly / Mosquitoes breeding shall not be permitted within the premises
26. Display and Exhibition of board: as per rule 3 of the Tamilnadu Prohibition of Smoking and Spitting rules, 2008,
 - Every person in charge of place of public work or use shall display and exhibit a board at a conspicuous place in or outside the place prominently stating that the place is as “ No Smoking and No Spitting Place” and that “ Smoking or Spitting here is an offence” which shall be in both Tamil and English and the version in English shall be in the Second Place below the Tamil. Tamil Version shall be written predominantly in the board by providing more space than English.

- No Sale of Tobacco , no smoking or chewing of tobacco inside the premises or institution (by the students, staff and teachers)
- Display of sign boards (No Smoking Area- Smoking Here is an offense) of at least 60 x 30 cms size inside the institutions at various locations.
- No sale of tobacco within the radius of 100 meters of the Educational institutions (Head master/ Principal Shall ensure).
- IEC Materials like Posters that give information about the ill effects of tobacco have to be displayed inside the institution and institution should have a copy of COTPA 2003 and rules, 2008
- Display of signboards on sale of tobacco produce around the institutions within 100 yards banned.

27. Building approval should be obtained from local body /DTCP, Chennai

This Certificate is liable to be cancelled at any time and infringement if any of the above said conditions and for the improper maintenance of sanitation & building and , if any , Health nuisance is found as defined in sec 3 of the Tamilnadu Public Health Act, 1939

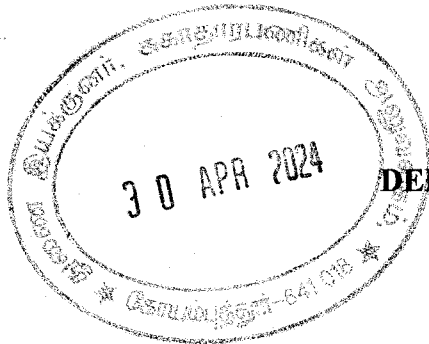
